

NOTICE TO BIDDERS

RECONSTRUCTION OF BROADWAY US ROUTE 20 TO BROADWAY VIADUCT BRIDGE AND REHABILITATION OF THE BROADWAY VIADUCT BRIDGE OVER CSX AND AMTRAK RAILROADS CITY OF RENSSELAER, NEW YORK

Sealed bids will be received by the City of Rensselaer Clerk at: 62 Washington Street, Rensselaer, NY, 12144 until 3:00 p.m. August 18, 2011, at which time they will be publicly opened and read.

The work site is located on Broadway at the intersection with US Route 9/20 (Columbia Turnpike) and extends 0.9 miles to Partition Street. The work also includes reconstruction of Broadway, a portion of Third Ave., Second Ave., and the entrance ramp to the Dunn memorial Bridge, creating a new intersection at the Broadway/New Broadway Intersection, as well as rehabilitation of the Broadway Viaduct Bridge.

The work includes providing all labor, materials, machinery, tools, equipment and other means of construction necessary and incidental to the completion the work shown on the plans and described in these specifications including, but not necessarily limited to the following: Full depth roadway reconstruction, new sanitary sewer, new water main, new storm drainage system, five stormwater treatment units, landscaping and decorative lighting, traffic signal installation, greeting wall, and bridge deck repair.

A complete set of the drawings, specifications and bid forms may be obtained in electronic format on Compact Disc (CD) in PDF format at no cost from the offices of CHA, III Winners Circle, Albany, NY 12205. Additional copies can be purchased for \$10.00 at CHA. Check should be made payable to City of Rensselaer.

All bids must be made on the official Bid Form and Bid Summary Form or an exact copy by reproduction thereof and enclosed in a sealed envelope. This is a unit price bid as described in the Instructions To Bidders. No Bidder may withdraw his bid within forty five calendar days after the actual date of the opening thereof. Each bid must be accompanied by a bid security in the amount of five percent of the base bid in accordance with the Instructions To Bidders.

The City of Rensselaer encourages Minority and Women's Business Enterprises (M/WBE) and Section 3 firms to apply.

The successful Bidder will be required to furnish construction performance and payment bonds in the full amount of the contract price. The successful bidder will also be required to furnish a surety bond for the NYSDOT Highway Work Permit in the amount of \$100,000.

The successful bidder will be required to comply with all provisions of the Federal Government Equal Employment Opportunity clauses issued by the Secretary of Labor on May 21, 1968 and published in the Federal Register (41CFR Part 60-1, 33 F.2 7804). The successful bidder must also comply with all provisions of the New York State Housing Trust Fund Corporation's CDBG program.

Owner reserves the right to reject any and all Bids, to waive any and all informalities and the right to disregard all nonconforming, non-responsive or Conditional Bids.
