## Failure to Answer:

Upon the failure of a person or owner of a vehicle to appear or answer a summons on or before the return period or any subsequent adjourned date, late penalties shall be imposed so follows:

If the aforementioned fine shall not be paid within twenty (20) days from the date summons was issued, a late penalty equal to the original fine shall be added to the fine; and

If the fine is still not paid within sixty (60) days from the date the summons was issued, on additional late penalty in an amount equal to the original fine shall be added to all fines and penalties previously assessed; and

If the fine is still not paid within ninety (90) days from the date the summons was issued, an additional penalty of thirty (\$30) dollars shall be added to all other fines and penalties previously assessed.
