# BUDGET VOTE Tuesday, June 9 Absentee Ballot Received by 5 p.m.

## What am I voting on?

Voters will decide on the following items:

- A \$27,705,833 budget for the 2020-2021 school year
- Lease of two school buses
- 1 Board of Education Position

VOTER QUALIFICATIONS: All voters must be United States citizens, age 18 or older on Election Day. Voters must be residents of the Rensselaer City School District for 30 days immediately prior to Election day and registered to vote.

In accordance with Executive Order 202.26, the 2020-2021 budget for all New York State School Districts will be conducted entirely by absentee ballot. As such, Rensselaer County Board of Elections will mail absentee ballots directly to all registered voters in the district of Rensselaer. Absentee ballots must be received by the Rensselaer County Board of Elections not later than 5:00 p.m., prevailing time, on Tuesday, June 9, 2020.

Absentee ballots will contain the three propositions voters will be asked to vote on, including the 2020-2021 school budget, the leasing of two buses, and one board of education member.

### Members of the Rensselaer City School District Community,

There is no doubt that we are in difficult times. If you have not already seen in the news or heard around town, our school district is in a financial emergency. Rensselaer was already identified as a school district "susceptible to fiscal stress". We had a strategy to try to solve this situation over time without taking opportunities from kids or putting a large burden on taxpayers. That strategy was dependent upon the state continuing to demonstrate a fiscal understanding of high needs districts like us by providing large aid increases. Now that the COVID-19 pandemic has completely changed the fiscal outlook of the state that strategy will no longer work. We now may see aid decreases instead. The result of these factors is a fiscal emergency for the district.

In order to not run out of money next year, we had to take a balanced approach. We started by reducing 7.5 positions, cutting many supplies and contractual expenses, and reducing budgeted athletic costs. If we continue to rely on our savings at a sustainable amount, we still need to increase the tax levy by 19.5%. We are aware that this is a large commitment by everyone involved. It is painful.

We hope to get through this without having to take away the extra-curricular, athletic, and academic support opportunities that our students deserve. 



Should the voters defeat the 2020-21 proposed budget twice (pending further executive orders), the Board of education would be
obligated to adopt a contingency budget. A contingency budget requires that the tax levy be no greater than the levy of the prior
year. After eliminating approximately \$128,000 in non-contingent expenditures, the budget would need to be reduced. A possible,
but not the final, allocation of the contingent budget is reflected in the third column of this "notice" labeled "Contingency Budget
for the 2020-21 School Year".

# **Rensselaer City School District Budget Propositions**

#### **PROPOSITION #1**

SHALL the Board of Education of the Rensselaer City School District be authorized to spend the sum set forth in the budget in the amount of \$27,705,833 during the 2020-2021 school year and to levy the necessary tax therefore. Adoption of this budget requires a tax levy increase of \$1,498,642, which exceeds the statutory tax levy increase limit of negative \$276,976 for this school fiscal year and therefore exceeds the state tax cap and must be approved by sixty percent of the qualified voters present and voting.

#### PROPOSITION #2

SHALL the Board of Education of the Rensselaer City School District, Pursuant to Chapter 472 of the Session Laws of 1998, be hereby authorized to lease and expend therefore, including costs incidental thereto and the financing thereof, an amount not to exceed the estimated maximum cost of forty-five thousand (\$45,000) dollars, and for a term not to exceed five (5) years, the following motor vehicles: two (2) seventy-two passenger school buses; AND, that such sum, or so much thereof as may be necessary, shall be raised by the levy of a tax collected in annual installments; and that in anticipation of such tax, obligations of the District shall be issued.
