Sealed bids will be received by the City of Rensselaer Clerk (62 Washington Street, Floor 2, City of Rensselaer, New York 12144) until 10:00am, February 12, 2021, at which time they will be publicly opened and read aloud.

The proposed project is located within the City of Rensselaer, Rensselaer County, New York.

This project is being progressed through the New York State Statewide Pedestrian Safety Action Plan under PIN 1760.94. Construction will be in strict conformance with all NYSDOT and Federal Aid Requirements and governed by the NYSDOT Standard Specifications Section 100 – General Provisions and Section 200 thru 700 - Technical Specifications.

The City of Rensselaer has included specific provisions and requirements, which are included in the project manual. Should there be any discrepancies between NYSDOT and the City of Rensselaer requirements, the more stringent shall apply.

There is a 6% Disadvantaged Business Enterprise (DBE) Utilization Goal for this project.

The work includes providing all labor, materials, machinery, tools, equipment and other means of construction necessary and incidental to the completion of the work shown on the plans and described in these specifications including, but not necessarily limited to the following:

The project is a pedestrian safety project located at (5) intersections throughout the City of Rensselaer. The (5) intersections are as follows; Washington Ave/7th St, Broadway/Partition St, Broadway/Pine St, Broadway/McNaughton Ave, and 3rd St/Catherine St. Included in the project are the construction of new curb ramps, pedestrian signals, and new/updated pavement striping.

Contract documents will be provided electronically on the City's website at <http://www.rensselaerny.gov>. Hard copy full and partial plan sets will not be distributed. Drawings and Specifications may be examined at the City of Rensselaer City Clerk's Office, 62 Washington Street, Floor 2, City of Rensselaer, New York 12144. Contractors that obtain contract documents from a source other than the issuing office must notify the issuing office in order to be placed in the official plan holder's list, in order to receive addenda and other bid correspondence. Bids received from contractors other than those on the official plan holder's list will not be accepted.

Addenda will be posted on the City of Rensselaer's Website, interested vendors are urged to check before submitting their bid.

The City will not issue Addenda, nor will its Engineer issue addenda nor respond to bidder's questions five (5) days prior to the scheduled bid opening unless stated bid date is postponed.

All bids must be made on the official Bid Form and Bid Summary Form or an exact reproduction thereof and enclosed in a sealed envelope with the following clearly marked on the front of the envelope:

Bid proposals that are "overnight" or otherwise shipped must be received by 10:00am local time on the day of the bid opening. Bids received via "overnight" or "express" mail after this time will not be opened and will be returned to the bidder. Such bids shall not be considered.

This is a Unit Price bid. No bidder may withdraw his bid within forty-five (45) calendar days after the actual date of the opening thereof. Each bid must be accompanied by a Certified Check or Bid Bond, payable to the City in the amount of 5 percent of the base bid in accordance with the Instruction to Bidders.

The successful bidder will be required to furnish construction performance and payment bonds in the full amount of the contract price.

The successful bidder will be required to comply with all provisions of the Federal Government Equal Opportunity clauses issued by the Secretary of Labor on May 21, 1968 and published in the Federal Register (41 CFR Part 60-1, 33 F.2 7804).

Owner reserves the right to reject any and all Bids, to waive any and all informalities and the right to disregard all nonconforming, non-responsive or Conditional Bids.
