RESOLUTION DECLARING NOVEMBER 2021 PANCREATIC CANCER AWARENESS MONTH IN THE CITY OF RENSSELAER, NEW YORK

WHEREAS, it is estimated that in 2021, 60,430 Americans will be diagnosed with pancreatic cancer, and 48,220 will die from the disease, approximately 3,400 of whom live in New York State, and

WHEREAS, pancreatic cancer is the fourth leading cause of cancer deaths in the United States in both men and women, and

WHEREAS, the symptoms of pancreatic cancer can go unnoticed until the cancer is in the advanced stages. Only six percent of those diagnosed survive five years and most with advanced cancer die within a year, and

WHEREAS, November 18, 2021 is World Pancreatic Cancer Day which marks a global effort to significantly raise the profile and awareness of the disease and people are asked to wear "Purple for a Purpose", and

WHEREAS, the Common Council of the City of Rensselaer supports those patients currently battling Pancreatic Cancer, as well as to those who have lost their lives to the disease, and are committed to nothing less than a cure, and

WHEREAS, the good health and well-being of the residents of Rensselaer are enhanced as a direct result of increased awareness about pancreatic cancer and research into early detection, causes and effective treatments.

NOW, THEREFORE, BE IT RESOLVED that the Mayor designate the Month of November 2021 as "Pancreatic Cancer Awareness Month" in Rensselaer, New York.
